Know all by these presents, that the undersigned hereby makes, constitutes and appoints each of Ilan Ganot, Jennifer Ziolkowski, Daniel Finkelman and Josiah Craver, acting individually, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:

(1) execute for, and on behalf of, the undersigned, in the undersigned's capacity as an officer, director and/or 10% beneficial owner of Solid Biosciences Inc.
